Granting of non-graded credit points (ECTS)

Regulations for the Degree of Doctorate §8(1) 4:

Proof of 10 credit points in the context of continuing academic education. The doctoral committee decides on the recognition of these credit points

Activities that can be performed in return:

- Participation in scientific conferences with own presentation (poster or talk), documented by the conference programme (e.g. screenshot of the conference page and screenshot of the abstract of your own presentation/poster).

for conferences on one or two days: **1 ECTS** each

for conferences lasting three days or more: **2 ECTS** each

- Participation in research colloquia (of your own or other working groups). Own contribution (talk) and attendance of 10 further talks given by other lecturers. There is no time limit for attending the presentations (i.e. not all of them have to take place during one semester, for example).

Confirmation of attendance by the lecturer or supervisor.

The form below is to be used for the confirmation.

1 ECTS each for a separate talk

- Visit to a laboratory/working group/research institution outside Leipzig with own scientific lecture. Lecture confirmed by a certificate from the host laboratory/working group/research institution.

1 ECTS for each visit

- Attendance of courses or modules (e.g. offered as part of B.Sc. and M.Sc. degree programmes) at a university with own contribution (e.g. exam, presentation, term paper). Type of own contribution and number of ECTS credits in accordance with the ECTS (or credit points) specified in the module description/examination regulations.

Recognition of a maximum total of **3 ECTS** for the entire doctorate

- Participation in scientific training programmes with own contribution (e.g. courses as part of graduate programmes, workshops, methods and statistics courses, interdisciplinary statistics courses, interdisciplinary qualification courses, summer schools, etc.).

Your own contribution can, for example, consist of practical exercises, creating programming code, carrying out statistical analyses in exercises and homework, presentations homework, presentations or examinations (this list is not exhaustive).

For each 15 teaching hours (45 minutes each) in attendance plus preparation and follow-up work (25-30 h workload in total) **1 ECTS** each can be granted. For a single continuing

education programme maximum of 2 ECTS can be awarded (i.e. for continuing education courses of 15 hours 1 ECTS, from 30 hours 2 ECTS).

Further education courses that comprise less than 15 teaching hours in attendance can be bundled, whereby 1 ECTS is awarded for a bundled length of 15 hours **1 ECTS** is awarded. Several bundles of continuing education courses can be submitted, for each of which 1 ECTS is awarded.

Proof of further training is provided in the form of a certificate of attendance. It is recommended that you use the attached template to provide evidence of the scope of the further training and the nature of your own contribution.

Activities must come from at least two of the areas mentioned.

The doctoral committee decides on the recognition of further activities.

These new regulations on the awarding of ECTS points come into force on 8 April 2024.
